ARTICLES OF INCORPORATION

0F

LE JARDIN CONDOMINIUM ASSOCIATION, INC.

The undersigned, by these Articles, associate themselves for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes and certify as follows:

ARTICLE I

NAME

The name of the corporation shall be:

LE JARDIN CONDOMINIUM ASSOCIATION, INC.

whose address is 4200 Gulf Shore Boulevard North, Naples, FL 30940. For convenience, the corporation shall be referred to in this instrument as the Association.

ARTICLE II

DURATION

The duration of the Association shall be perpetual.

ARTICLE III

PURPOSE

The purpose for which the Corporation is organized is to provide an entity pursuant to the Condominium Act, Chapter 718, Florida Statutes for the operation of

LE JARDIN, a Condominium,

to be located upon the following lands in Collier County, Florida:

Thence North 70°35'10" West for a distance of 108.48 feet to a point of intersection with a non-tangent curve from which the radius point bears North 34°22'41" West, said point of intersection being on the Easterly line of Commons "T" of said Plat of Park Shore Unit Number 2; Thence, Hortheasterly and Northerly along said Easterly line and along nence, Northeasterly and Northerly along said tasterly line and along said curve, concave Northwesterly and Westerly, having a radius of 140.00 feet, a central angle of 58°16'11" for an arc distance of 142.38 feet to a point of intersection with a non-tangent line, said point of intersection being on the Southerly line of said Lot 15;

The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.
